4. Chairman's personal review of the year 2023/24

The Chairman said that during the year the Parish Council welcomed the co-option of Cllr Jacqueline Jackson. The Clerk has returned to work after being ill for the last 6 months of 2023. The playground renovation project is progressing and it is hoped will be installed during the summer.

Opportunities that are presenting themselves include the further development of successful parish 'partnerships'. The Scarecrow Festival is now established on the King George V field; the new village sign has been installed; the Harlow Theatre Company continues to use the pavilion and has been responsible for its refurbishment. As previously mentioned, the playground project is nearing completion, and the Parish Council continues to engage with local organisations and businesses.

Challenges being faced include the Harlow North/Gilston Garden Town development, together with other local developments and including concerns about a proposed traveller site within the village boundary. The state of the roads remains a problem, including the number of potholes and damage caused to roads and property by the large number of HGV movements through the parish. Speeding and parking issues continue to cause concern, especially around school pick-up times. The maintenance and renewal of assets remains under consideration.

Finally the Chairman acknowledged that ClIr David Smith had announced his intention to retire from the Council, but extended thanks and appreciation to him for agreeing to stay in office for the time being.

9. Open forum: Matters raised by the public

Concerns were raised about overgrown hedges narrowing the width of footways at various locations in the village, the concern included the additional hazard created by pyracantha hedging that has dangerous thorns. The problem is particularly acute for older residents

The erosion and loss of road markings is also a problem. The Chairman agreed to ask Manor of Groves to deal with its hedge that is overhanging the road, and also to ask Herts Highways to reinstate missing road markings.

There being no further business, the Chairman thanked everyone for attending and closed the meeting at 7.45pm.
